

# MARINE RESCUE NSW FORSTER/TUNCURRY TUNCURRY MARKETS

## Conditions And Code of Conduct to be Complied With By Stall Holders

---

1. The Tuncurry Markets are generally held at John Wright Park on the 4th Saturday of every month from 8:00AM to 1:00PM (weather permitting).
2. Decisions to cancel any market day because of inclement weather will be made the evening prior to the markets by the Marine Rescue Commander. If in doubt on the morning of markets, please contact the market coordinator. 7:00AM on the morning of the Market Day itself. Please call the Market Co-ordinator if you are unsure.
3. Any decision made by the Market Co-ordinator regarding the stall allocation or eviction of stall holders shall be final, and no further correspondence will be entered into.
4. The following conditions apply and must be agreed to by attending stall holders:
  - (1) A fee of \$25 will be paid for a 3 metre x 4 metre site, \$40 for a double site 3 metre x 8 metre. The fee for provision of power to a site is an additional \$10.
  - (2) All stall holders MUST have Public Liability Insurance for \$10 million dollars. A copy of your policy must be handed in to the Market Co-ordinator PRIOR to stall set up. All policy renewals are to be handed in annually at the Oct market (Rates for Insurance vary - we advise stall holders to shop around for their best rate)
  - (3) All regular stall holders must be on the site by 6.30am. If a stall holder cannot be on site by 6.30am - arrangements may be made with the co-ordinator for a later arrival time. Failure to notify the Co-ordinator may result in the site being reallocated.
  - (4) Closing time for the market is 1:00PM and NO vehicles are to be on the park prior to this time. All stall holders are to be off site by 2.30pm and sites are to be left clean and tidy.
  - (5) Car parking in the vicinity of stalls is at the discretion of the co-ordinator and is dependent on the location of the stall.
  - (6) Market customers expect the markets to operate between the advertised times of 8:00AM and 1:00PM. Stall holders are **NOT to pack up early**. The exception to this rule will be the onset of rain or strong winds during the morning.
  - (7) Should any stall holder wish to keep their designated site and cannot attend an advertised Market are to notify the co-ordinator by Friday 8 pm.
  - (8) Failure to attend two consecutive market days without notification will result in the stall holder relinquishing their current site. This condition does not apply should the market be cancelled.
  - (9) All stall holders are responsible for the safety and security of their own stock.
  - (10) Stall holders will complete an application form which includes a description of the type of goods that they are offering for sale.
  - (11) Stall holders are **NOT** permitted to change the type of goods/service they offer for sale without consent of the Market Co-ordinator.
  - (12) Smoking or Alcohol consumption will **NOT** be permitted on the market site or in the proximity of other stallholders by any stallholder.
  - (13) Anti-social behaviour and bad language by any stall holder will not be tolerated and may result in eviction from the market.
  - (14) Pets are not permitted at any stall.
